### **Off-Campus and Distance Education Degree Programs**

UCSF and California State University, Fresno have designed a new Joint Doctoral Degree in Physical Therapy that is scheduled to enroll its first class of students in Fall 2007. Most of the coursework will take place in Fresno, with some classes being offered on weekends in San Francisco. This program, which will address the growing demand for physical therapists in the San Joaquin Valley, has been approved by both campuses and their respective systemwide offices. It is awaiting final approval by WASC.

## **Institutional Stipulations**


